President's Message

Dear EHPS Colleagues,

In this message I will report on several new developments within the Society, which reflect a very positive movement within EHPS in terms of consolidation and gradual expansion.

I am very pleased to report that the European Health Psychology Society has completed the process of legalisation in the Netherlands on January 12, 2004. This is an important step for the consolidation of the Society as a legal entity and its future development.

We have also made good progress in linking up with other Societies. APA Div. 38 has invited EHPS to publish a feature article on the Society in the Division Newsletter. We hope that this initiative will get American colleagues more acquainted with EHPS and will foster further collaboration. The International Association of Applied Psychology will for the first time sponsor a symposium in the Helsinki Conference (Chair: Esther Greenglass) and EHPS is sponsoring a symposium for the ISBM biannual conference for the second time (Chair: Susan Michie). We hope that these initiatives will bring new forms of collaboration while increasing international visibility for EHPS.

Inside this newsletter you will find important information regarding the <u>Helsinki</u> <u>conference (21-24 June)</u>. The local organisers are preparing an exciting social program. As a member of the scientific committee, I am happy to report that the conference is gathering a high quality program, which will offer good coverage of its main topic: *Good Health: Person and Context*.

I would like to call your attention to the <u>April 17th deadline for poster submissions only</u>. The scientific committee is providing fast track evaluation of submissions in order to help interested participants to register early. Organisers encourage participants to register and book accommodations as soon as possible. I would also encourage members to pass on this information to your health



psychology colleagues and students (an E-mail with the EHPS Newsletter will do). EHPS conferences are an excellent opportunity to get acquainted with the Society and to network within the field of health psychology.

In the Newsletter are also updates on the <u>Synergy and Create workshops</u>. Please note their deadlines. This year the Society was able to provide seven grants to researchers making proof of hardship, in order to attend the conference, the Create and Synergy workshops. This is an attempt on the part of the Society to invest in facilitating access to these important initiatives to young researchers and graduate students, starting early involvement in EHPS collaboration.

Part of the democratic functioning of our Society are regular elections, which will allow members to get involved in the future development of the Society and will bring healthy renewal to its governing bodies. These elections are governed by the Articles and Bylaws approved in the last Member's Meeting. I call your attention to the Call for Nominations for the Executive Committee of EHPS 2004-2006. Members will receive nomination forms by E-mail or post until the end of March. I would like to encourage you to get involved by either accepting being nominated or nominating someone to the Executive Committee. There are many diverse functions in the EC and I think that I can speak for my EC colleagues when I state that this experience is very enriching both personally and professionally.

Dear EHPS members,

In accordance with the articles and bylaws of the EHPS, which define the procedure for the elections of the Executive Committee, we are proceeding with the respective Call for Nominations as detailed below. This is an opportunity for you to take a more active part in the Society because you have the possibility of nominating candidates for the EC, members that in your opinion can make a valuable contribution to the future of the Society and can represent your point of view.

The term of the current EHPS Executive Committee will expire in June 2004 (Helsinki Conference). I am, therefore, writing to you to encourage you to provide nominations for the new Executive Committee. In accordance with the Articles and Bylaws of the Society, any member of the Society who has been a member for at least 2 years by this time is eligible for election unless he/she is already time-expired as a member of the Executive Committee. The SYNERGY annual three-day workshop is organised to provide an opportunity for synergistic discussion between health psychologists conducting research in core fields within health psychology. The focus is on advancing the standard of work within the field by pooling expertise, haring critical evaluations, and stimulating networking and collaborative research between researchers from all over Europe in an informal and supportive atmosphere.

The aim is to develop improved theoretical and methodological approaches, as well as practical applications in respect of the workshop topic. It is an opportunity for researchers to present their research for discussion in depth with other experts working in the same field in a friendly and relaxed atmosphere. By focusing on a core topic on which all participants have some expertise and have conducted research (published and unpublished), we would expect to reach a shared understanding of the strengths, weaknesses and opportunities in the area. We hope that this will influence future research and its application in the field.

Facilitators will guide the work and support and moderate the discussion. This year's SYNERGY workshop on Illness representations will be facilitated by:

- Prof. John Weinman, King's College London, UK, and
- Prof. Keith Petrie, The University of Auckland, New Zealand.

The workshop will provide opportunities to develop new ideas, approaches or methods for understanding or working with patients' beliefs. Subgroups will work on the upcoming themes in more detail. Participants will be encouraged to use different kinds of working methods like individual presentations, discussion, teamwork in smaller groups, etc. In order to disseminate the newly gained insights to a broader audience, participants will be expected to present their ideas at a round table or special symposium at the EHPS conference. The workshop will be held at the University of Helsinki.

SUMMER COURSES University Maastricht The Netherlands

Course 1: 28 June- 2 July 2004

Health Education and Health Promotion: Theory and Practice.

The goal of the course is to provide an overview of important relevant theoretical perspectives, taking the educational approach as the starting point. This year will focus on the importance of a planned approach. Moreover, important emphasis will be given to social psychological theories (e.g. social learning theory, the theory of planned behaviour, attribution theory, relapse prevention), by conducting in-depth discussions concerning the role of attitudes, social influences and self-efficacy in the process of behavioural change. Moreover, substantial attention will be given to the application of these theoretical principles into practice. This will be achieved by working together in small groups on a mutual problem. Costs: €795 when registered before May 1, otherwise €840. Course Leaders: Prof. Dr. Hein de Vries, Ph.D. & Dr. Ilse Mesters, Ph.D.

Course 2: July 5-9, 2004

Intervention mapping for Aids prevention: designing theory-based and evidence-based interventions

The goal of the course is to focus on developing theory-based and evidence-based health education and promotion programs for Aids prevention. The emphasis of this course will be on applying the Intervention Mapping process to the development of Aids prevention programs. Intervention Mapping is a new process for the creation of health education programmes, in which the educators are guided through a series of steps that will assist them in theory-based and evidence-based intervention development. Costs: € 1175,- including course materials. Course Leader: Prof. Dr. Gerjo Kok, Ph.D.

Calls for Papers

"Childhood Chronic Illness: Reciprocal Impact on Parent and Child Relationships"

Health Psychology is requesting empirical papers that focus on children or adolescents with chronic illness. The focus of this special section is on the reciprocal impact between parent and child. That is, papers must in some way address the effect of the family on the child as well as the effect of the child on the family. Studies must present both family and child outcomes. One of the major outcomes must represent either physical health or health behaviour (e.g., adherence). Parental reports of child outcomes are not sufficient. Studies that have developed innovative methodologies to study these issues will be given priority. Longitudinal studies are especially welcome. Some examples of topics that fit the theme of the special issue are:

- o outcomes of family therapy interventions
- o studies of family interactions
- studies that address the effects of parent mental health on child as well as child characteristics on parent
- o studies that examine the effects of the illness on both children and families
- o studies that examine the parent-child relationship from both perspectives
- o studies that examine the effects of the marital relationship on the child as well as the child on the marital relationship

The theme of the Congress is "Europe – Our Common Home?"The Congress will take place at the Humboldt Universitat, in the very centre of the city. The opening and closing ceremonies will be held at the Haus der Kulturen der Welt/Kongresshalle (House of World Cultures/ Congress Hall) located in a beautiful park, the Tiergarten. The Haus der Kulturen der Welt/Kongresshalle can easily be reached by public transport. The local organiser is the Deutsche Gesellschaft fur Osteuropakunde (German Association for Eastern European Studies).

The theme of the congress is "Europe – Our common Home?". Childlessness, Adoption, and Other Reproductive Complexities

Please join the members of the Gender, Infertility, and Adoption Study Group of University of Michigan's Institute for Research on Women and Gender (IRWG) for an international conference devoted to the theme of "Reproductive Disruptions: Childlessness, Adoption, and Other Reproductive Complexities." This conference will be devoted to asking what happens when reproduction is, for one reason or another, problematized. What do reproductive falterings and failures, miscommunications and outright battles—or the politically and emotionally charged contestations that take place in the everyday reproductive experiences of women and men around the world—tell us about the subtleties of culture and power in everyday life? How is our understanding of so-called normal reproduction enhanced when we take reproductive disruptions, such as infertility, pregnancy loss, genetic disorders, and childhood disability, into account?

This third international conference at the University of Michigan, Ann Arbor, will be devoted to a broad range of reproductive topics including (but not limited to): local practices detrimental to safe pregnancy and birth; conflicting reproductive goals between women and men; the contested meanings of abortion; intentional reproductive loss through sex-selective feticide and female infanticide; miscommunications between pregnant women and genetic counsellors; cultural anxieties over infertility, adoption, donor parenthood, and childhood disability; the globalisation of new reproductive technologies; and feminist critiques of the "new eugenics". This breadth—with its explicit move from the local to the global, from the realm of everyday reproductive practice to international programs and policy-making—demonstrates that the notion of reproductive disruption is productive for examining the meanings of difference, the workings of power, and the tensions between women's (and men's) reproductive agency and various structural and cultural constraints. expanding the arena of reproduction disruption to include topics like nurturing of biological and adopted children, medical communication, male-female reproductive negotiation, and the (mis)uses of reproductive technologies, the conference is likely to move the social science of human reproduction into new and important spaces.

New Books

Between Stress and Hope, Praeger

Rebecca Jacoby & Giora Keinan

The book's title, *Between Stress and Hope*, embraces two meanings. One relates to the transition which psychology underwent during the 20th century from an almost exclusive focus on anxiety and stress to an occupation with optimism and hope. This reflects a more general process of transition from the pathogenic model that focuses on illness and vulnerability to a salutogenic model that focuses on health and resilience. The second relates to the transitions between stress and hope often experienced by individuals or groups exposed to stressful circumstances.

The book contains three parts. The first part discusses the theoretical aspects of stress and hope as well as the nature of their interrelationships. The chapters included in this part represent the most updated thinking on the concepts of hope and optimism. The second part deals with coping processes of individuals or groups that have been exposed to various situations of stress, and illuminates the role of hope in these processes. The situations include a variety of psychological, physical and social stressors, such as racial prejudice, illness and imprisonment. The third part of the book presents two therapeutic approaches demonstrating the application of the knowledge and understanding of the 'work of hope' in psychotherapy, either by means of working through the body, or by using literature.

We hope that in these times, when the world is exposed to extreme threats, the materials presented in this volume will aid clinicians and researchers to unravel the inner workings and the complexity of human beings facing these threats and stimulate new directions for research.

Erratum in Poster publication presented at the 2003 EHPS Conference in Kos. Greece

TITLE: EXPLORING CROSS-CULTURAL DIFFERENCES IN ATTITUDES TOWARDS SMOKING: THE CASE OF UK AND HELLAS.

A survey about lifestyles within the European Union conducted by Eurostat confirms differences in smoking behaviour between UK and Hellas with the Hellenic population having the worst smoking record among all the European

countries. This research report demonstrates the findings of a pilot study within a group of 16-18 adolescents from UK and Hellas in order to explore potential cross-cultural differences in attitudes towards smoking. The theory that provides the most appropriate context without the limitations of a specific culture is George Kelly's (1955) personal construct theory. Kelly's repertory test is applied for eliciting personal constructs about smoking from smokers, non smokers and ex-smokers in both countries, by using pictures of smoking situations as common sets of photo -elements. The qualitative analysis of the result suggests that there are some limited cross-cultural differences in attitudes adolescents have. However, these differences do not represent a different way of construing about smoking, but they reflect the absence of social policy in Hellas compared to the growing anti-smoking policy in UK, on the other hand. Additionally, the adolescents in both countries have construed in a similar way about smoking, irrespective of their smoking status which suggests that they are psychological similar in a Kellyian sense. Nevertheless, they have different idiosyncrasies hence explore the word in a, perhaps, different way and they cannot be viewed as a homogenous group. Finally this study suggests that blaming adolescents for their smoking behaviour or trying to protect them in an unrealistic way is not productive. It would be more fruitful for educators to apply Kelly's approach to health promotion in order to explore individual differences and place the emphasis on personal growth, development and empowerment of the individual

University College London PhD Studentship in Health Psychology

Applications are invited for a PhD research studentship in Health Psychology. Students who have or are expected to attain a 2.1 or first class honours degree in Psychology or a related discipline are invited to apply. A relevant Master's degree is desirable. The 3-year PhD studentship, funded by the Infection Control Society, will take effect from October 2004.

The PhD will investigate health professional behaviour in relation to the prevention of health care associated infections (i.e. hand hygiene and sharps disposal behaviours). A theoretical framework developed to understand clinical guideline implementation will be applied in a series of studies culminating in the development and evaluation of an intervention. The studies will involve a systematic literature review, measure development and the collection of both qualitative data (interviews) and quantitative data (questionnaire, observational and routinely collected clinical data). The project will be overseen by a multidisciplinary group, including a consultant in occupational health, a consultant microbiologist and a systematic reviewer.

The studentship includes a stipend of £14,000 per year for 3 years and includes full provision for academic fees for UK-EU students. Non-EU (overseas) residents may apply and are still eligible for the stipend but will need to demonstrate how they will fund the difference in home/EU and overseas academic fees.
